6. The undersigned hereby authorizes and instructs the above mentioned banks and companies to release the information requested by Transnet, Inc.
7. In the event that Transnet, Inc. is forced to utilize an outside collection source to collect unpaid balances, then a revocation of all applicable discounts and allowances shall apply resulting in collection of gross charges.

I authorize Transnet, Inc. to communicate with freight carrier references and financial institutions with which we do business and credit organizations, in order to obtain any information that is necessary to determine my solvency for the purpose of opening this account. I understand and acknowledge that Transnet, Inc. has the right to change any credit terms granted to the above listed company at any time in the sole discretion of Transnet, Inc. without prior notification. Any failure(s) by the above listed company to timely pay any invoice(s) from Transnet, Inc. in accordance with the terms outlined herein may result in said company being liable for reimbursement of all resulting collection and/or attorneys' fees incurred by Transnet, Inc. Freight charges not paid when due may accrue interest at the rate of 1 1/2% per month, or the highest rate allowed by law, whichever is less.
